1. CALL TO ORDER

HUNT Chairman Hunt called the Regional Emergency Management Agency Cooperative

meeting to order at 7:55 p.m.

HOVIS Solicitor Hovis stated that the Regional EMA Cooperative consists of

Springettsbury, Spring Garden and Manchester members of YAUFR. He noted that it is a distinct and different board; however, it is made up of the identical members. The intent was to create a joint EMA that would professionally be overseen by the YAUFR staff, headquartered at YAUFR headquarters and run by

the YAUFR administrative staff.

2. ACTION ON MINUTES

A. Approval of Minutes: June 21, 2016 – EMA Meeting

MR. DVORYAK MOVED TO APPROVE THE MINUTES OF JUNE 21, 2016 – EMA MEETING. MS. PHAN WAS SECOND. MOTION CARRIED. MR. BROSEND ABSTAINED.

6. NEW BUSINESS

A. Approval - Updated version of EOP

HOFF Chief Hoff explained that the updated version of the EOP included the new board members of each of the three townships. Two facilities were added as far as those who had requested copies of the EOP.

HOVIS Solicitor Hovis explained that, in addition to approval of the minutes, since the plan had been updated it is this board's responsibility to approve the plan including the updates.

HUNT Chairman Hunt asked whether this board should reappoint Joe Madzelan.

HOVIS Solicitor Hovis responded that he continues in that position until replaced. He is approved by the Governor.

HUNT Chairman Hunt indicated that this board will act as the Regional Emergency Management Agency Cooperative and be the first board to approve the document. Following approval, it is sent to the three municipalities.

ROONEY Mr. Rooney had reviewed the documentation and noted that Harley-Davidson had been added to the Appendix. He asked whether there was some significance.

HOFF Chief Hoff responded that it is a SARA facility for reporting. There could be a half a dozen reasons why Harley's in there based on different processes and areas within the plant. That would be a special concern to us as Emergency Management.

ROONEY Mr. Rooney noted that it would not have to be an exhaustive list of all employees.

HOFF Chief Hoff indicated it would not.

MS. PHAN MOVED TO APPROVE THE UPDATED EMERGENCY OPERATIONS PLAN. MR. MOONEY WAS SECOND. MOTION CARRIED. MR. BROSEND ABSTAINED.

HUNT Chairman Hunt asked whether he was on the list inasmuch as he is not an elected official.

PHAN Ms. Phan noted that he had been elected at Springettsbury Township; approved and voted upon.
