1. CALL TO ORDER

SCHENCK Chairman Schenck called the meeting to order and led the Pledge of Allegiance.

A. Steve Hovis, Solicitor

The biggest issue to deal with is the inter-play between EMS, police and fire and who administers it. He and Chief Hoff continue to work on it, but in the end it will be better functioning coordinates for everyone.

B. Daniel Hoff, Fire Chief

HOFF Chief Hoff provided several updates to his monthly report. He announced that he had been elected to a two-year term on the Board of Trustees of the York County Fire Chiefs Association. He requested assistance with obtaining correct email addresses and street addresses for the two new Alternate Commissioners, Blanda Nace and Mike Thomas.
