## 1. CALL TO ORDER

- A. Opening Ceremony
- 1. Pledge of Allegiance
- **HUNT** Vice Chairman Austin Hunt called the meeting to order. He led the Pledge of Allegiance.

#### 2. ANNOUNCEMENT OF EXECUTIVE SESSIONS

**HUNT** Mr. Hunt announced that there had been no Executive Sessions since the last meeting, and none had been planned for this date.

## 3. COMMUNICATION FROM CITIZENS

There were no citizen comments.

#### 4. MANAGEMENT/ATTORNEY REPORTS

- A. Steve Hovis, Solicitor
- **HOVIS** Solicitor Hovis reported one update. He issued the final Alarm Ordinance to Solicitors Charles Rausch and Larry Young with a suggested road map as to how it is intended to be administered. He expected they would review the ordinance

with their governing bodies sometime in the future as to what that looks like and how it would be undertaken by each municipality. Feedback should come back to YAUFR Commission.

- **HUNT** Mr. Hunt questioned the current best practice for fire alarms. He asked what piece of hardware is in house and who it connects with.
- **HOFF** Chief Hoff indicated it goes to a monitoring company such as ADT or a similar service. It is actually addressed in the version mentioned in Solicitor Hovis' report. By Ordinance it would not go to the fire department.
- **HUNT** Mr. Hunt commented that it would involve a third-party buffer.
- B. Daniel Hoff, Fire Chief
- **HOFF** Chief Hoff reported that YAUFR's proposal was submitted to the Fire Chief's Board of Governors. They have an opportunity for the next month to review the proposal. After the meeting, he had received positive feedback from members of the board.
- **HUNT** Mr. Hunt asked what the anticipated timeline would be for action if they accept the proposal.
- **HOFF** Chief Hoff indicated that probably they will go through with their advertising and consider YAUFR's proposal with the other applications. He noted the timeline likely would be late summer.
- **HUNT** Mr. Hunt questioned whether it would be necessary to add staffing.
- **HOFF** Chief Hoff responded there would be a promotion from within and one addition as a Firefighter.
- **HUNT** Mr. Hunt asked whether there had been any change in attitude with having union representation at the Safety Committee meeting recently.
- **HOFF** Chief Hoff responded that it was a welcomed change as of about two weeks ago. He looked forward to that involvement.

- **HUNT** Mr. Hunt questioned Solicitor Hovis whether he had reviewed the minimum Manning brief that was in the packet with the decision by the Supreme Court.
- **HOVIS** Solicitor Hovis responded that he was aware of it. However, he had not reviewed it given the fact that there is no bargaining at this point in time. He offered to review it at some point.
- **HUNT** Mr. Hunt indicated that the tone of Pat Harvey's Executive Summary suggested to just be prepared.
