He had preliminarily approved the request and requested Commission approval. There were no incidents and no injuries. They basically covered the intersections within Springettsbury and Spring Garden Townships.

- MCCOY Chief McCoy brought forward an item involving a request from Grantley EMS. He reported that they do a lot of non-emergency events where they stand by and provide First Aid. Several had been previously approved during 2012. Six more requests had been received, and he recommended approval of all six. They are listed as follows:
 - MDA Concert presented by the Career Firefighters of Manchester Township, September 23, 2012. This is an MDA softball event that Grantley was requested to provide EMS service; this is all volunteer personnel.
 - Burn Session, York County Fire School, September 23, 2012 for stand by EMS service.
 - York College 5K Run on October 5, 2012.
 - York College Men and Women's Rugby Season.
 - Gettysburg College Ice Hockey Season ending in February 2013, held at the York Ice Arena.
 - Burn Sessions for YAUFR and Manchester Township also being conducted in October.
