1. CALL TO ORDER

A. Opening Ceremony

1. Pledge of Allegiance

DVORYAK Mr. Dvoryak called the meeting to order and led the Pledge of Allegiance.

2. ANNOUNCEMENT OF EXECUTIVE SESSIONS

DVORYAK Mr. Dvoryak announced that an Executive Session was held immediately following the last meeting.

3. COMMUNICATION FROM CITIZENS

There were no citizen comments.

4. MANAGEMENT/ATTORNEY REPORTS

A. Steve Hovis, Solicitor

HOVIS Solicitor Hovis noted that he had done some research concerning the Pension Board members. During the January meeting, a Resolution will be adopted appointing by name all the members of the YAUFR Commission as members of the Pension Board.

B. Daniel Hoff, Fire Chief

HOFF Chief Hoff reported that the draft advertisement was ready to begin advertising the apparatus to be sold.

HOVIS Solicitor Hovis clarified that the sealed bids for the apparatus will be awarded for the March meeting.

ZORTMAN Ms. Zortman questioned the Palmer dollhouse and whether it would be used for training purposes.

HOFF Chief Hoff responded that it is made out of OSB plywood. He described its height and noted that the construction is designed to show fire and smoke travel through a house based on various openings. By opening and closing different vents it demonstrates fire travel and the benefits of sealing off an area, such as recommending people to shut their bedroom doors at night for protection. He added that the dollhouse was in the apparatus bay for the board members to see. It could be used to train the public, as well as for some of the entry level volunteers and career staff for fire behavior lessons.

BROSEND Mr. Brosend suggested that perhaps it could be demonstrated to the board at some point.

ZORTMAN Ms. Zortman added that she would love to see it.

HOFF Chief Hoff indicated that would be great. He indicated that they will make that happen.

WURSTER Mr. Wurster asked if he had thought of putting up a You Tube video for that as well.

HOFF Chief Hoff responded that he had thought about it but they had just taken ownership of it within the last week and a half and they really hadn't done anything with it yet. He would like to do a You Tube video for YAUFR and have it uploaded to the Facebook page and the website.

WURSTER Mr. Wurster responded that he understood that it's brand new.

ZORTMAN Ms. Zortman asked about the house donated by Tim Pasch.

HOFF Chief Hoff responded that the house sits behind the strip mall on Stoneridge Road. Mr. Pasch is preparing to do some construction there, and he has a demo permit for the beginning of January. He offered it to YAUFR to do some training; breaking down doors and windows, running hose lines inside. The only thing YAUFR won't be doing is live fire training as DEP frowns upon that.

ZORTMAN Ms. Zortman commented that it was an awesome opportunity. She asked if those opportunities come very often.

HOFF Chief Hoff responded that they come occasionally; maybe one or two a year. It just depends on the timing and whether the owner is willing to wait a few extra weeks to

allow the opportunity. He noted the last one was owned by Springettsbury, the Snowberger property on Mt. Zion Road, and a lot of training was done with that before it was torn down.

ZORTMAN Ms. Zortman indicated that it was a really nice opportunity that caught her eye.

WINGERT Ms. Wingert noticed that Ms. Crawford had not responded back to Chief Hoff. She questioned whether this was an internship through a college.

HOFF Chief Hoff responded that Ms. Crawford was an intern. He indicated he had tried numerous ways to contact her but had not had any success. He wasn't sure if she had changed all her contact information and forgot to pass that along. The good news is that YAUFR is not out anything except some video footage that she did take, which obviously can be recreated. It is disappointing.

WINGERT Ms. Wingert asked if she was a Suburban or Central graduate.

HOFF Chief Hoff responded that she graduated from Central. He hoped to check during Christmas break to contact her.

WURSTER Mr. Wurster noted he had just found her Facebook page, if it is her, from York, PA.

HOFF Chief Hoff indicated he would try to find her on Facebook.

Each member of the team reviewed a specific area of the apparatus, i.e. the paint job and the coatings, the pump, the chassis, etc. Each one drilled down, and Chief stated he was very happy with the performance of the men. They were very satisfied with the product that is coming.

Chief Hoff reported that, with regard to this year's budget, a day or so after Lisa did the last check run for 2018, she received the invoice for Manchester Township to cover the pension costs. She plans to ask Jamie for a regular check that would need signed so that she could get that cleared instead of waiting for the next check run to come which goes into January. He mentioned it so that the board members won't be surprised if there is a need for a signature or two in a few days.
