#### 1. CALL TO ORDER

A. Opening Ceremony

## 4. MANAGEMENT/ATTORNEY REPORTS

A. Steve Hovis, Solicitor

HOVIS Solicitor Hovis commented on the discussion on the EMA Agreement.

Manchester had approved it. Spring Garden and Springettsbury were to approve it at their next meeting. The agreement had been reviewed and presented and it.

the retirement.

**SCHENCK** Chairman Schenck reported that Springettsbury had created and advertised an ordinance, which was passed and is in place.

B. Robert McCoy, Fire Chief

MCCOY Chief McCoy reported that the EMC Agreement was signed by all three parties. It will be held at this time pending the ordinance. It was confirmed that it does

not need to be sent to PEMA and York County.

## 6. BIDS, PROPOSALS & CONTRACTS

- A. Approval Stambaugh Ness Agreement for "IT" and Out Sourced Business Services
- B. Approval Stambaugh Ness Agreement for "IT" Support Services

MCCOY Chief McCoy reported that he and Lisa Einsig met with Stambaugh Ness two weeks ago to discuss potentially using them for IT Services. The transition is underway from using Springettsbury for finance and the change in payroll services and moving away from the MUNIS system. Stambaugh Ness presented a proposal and costs for their services. Three representatives were present to discuss their areas of expertise: Rick Hogentogler, Partner in Stambaugh Ness, Phil Keeney, Associate and Krista Gardner, Principle. A lengthy discussion took place which is summarized:

Goal – To review the migration from Springettsbury into a YAUFR IT hosting.

- Two components in proposal: IT and accounting needs from MUNIS to Quickbooks and specific steps necessary.
- Krista Gardner in charge of accounting and training of key steps in Quickbooks use; set up of Chart of Accounts.
- Phil Keeney in charge of IT support; indicates YAUFR internal support sufficient capability.
- Outside of internal capability, Stambaugh Ness will create engagement agreement for support at consultant rate of range between \$100/hr.; \$145/hr. or \$160/hr. depending on the complexity.
- Quickbooks conversion from MUNIS to CSV format in Quickbooks up front cost of \$7,000, which includes first year capital expenditure for operating system, software licensing @ \$2800/year with first year 20% discount; \$55/month/user for notes, posting and licensing.
- Internal process to be streamlined and eliminating unnecessary devices.
- Disaster recovery and defense security built in along with unlimited access to technical support.
- Spring Garden Township pleased with Quickbooks and support from Stambaugh Ness.
- Report customization would be on a consultant basis.
- Hosting could be through Stambaugh Ness, Right Networks or Soft Layer.
- Access to remote desktop service link leads directly to the server.
- Stambaugh Ness operates independently so no conflict of interest for auditing.
- Programs are web focused; file storage transitioning to Office 365.
- Anticipated start date July 1, 2016.

## **SCHENCK** Chairman Schenck questioned Solicitor Hovis as to the appropriate way to move forward.

HOVIS Solicitor Hovis suggested to approve the proposal conditioned upon a review by himself and Chief McCoy. If the final contracts are acceptable to them, the contracts would be authorized for signatures at that point.

MR. SCHENCK MOVED TO ACCEPT THE PROPOSAL FROM STAMBAUGH NESS FOR THE BUSINESS SYSTEMS CONDITIONED UPON SUCCESSFUL EXECUTION OF THE ENGAGEMENT LETTER AND THAT THE ENGAGEMENT LETTER CAPTURES ALL THE CENTRAL POINTS OF THE PROPOSAL; AND FURTHER AUTHORIZE THE CHIEF AND THE SOLICITOR TO REVIEW AND NEGOTIATE THE FINAL TERMS TO BE EXECUTED BY THE APPROPRIATE COMMISSIONER. MS. PHAN WAS SECOND. MOTION UNANIMOUSLY CARRIED.
