TRAINING

• YAUFR members completed a total of 14,257 training hours in 2021.



• During the 4th quarter of 2021 crews focused on training in the following areas: Fire Ground Operations (ICS / NIMS Review, Single Family Residential Fires, Multi-Unit Fires, Thermal Imager Operations, Reading Smoke, Flow Paths, Flammable liquids & Gases, Heating Emergencies and Cold weather pump operations) and Planning and Prevention (Preplanning, Codes and Fire Prevention).



TRAINING - CONTINUED

• On November 4, 2021, Crews assisted Life Team EMS with their Stress Induced Competency Assessment Day at the York County Fire School. Our staff assisted with instruction and working through various rescue scenarios that allowed the students to put their acquired skills into practice. We are proud to continue aiding with the education of new providers and strengthening our relationship with our EMS partners.

• Annual fall company level burn training was conducted on October 20th, November 3rd, and November 17th. Crews worked through decision making scenarios relative to fires in multi-family structures.

• Bi-Annual CPR/AED training was completed for 2nd Battalion Personnel on October 18th, 22nd, and 26th.

• Remember to check your EMT con-ed status. Personnel are reminded to ensure all required con-ed is submitted and the recertification application is completed in a timely manner to avoid any issues before your certification expires.

• Please forward copies of training certificates that you receive so we can keep your training records current.

YAUFR STRATEGIC PLAN

Throughout 2021, a 30-member strategic planning committee, comprised of internal and external stakeholders, worked diligently to develop a draft YAUFR strategic plan for 2022-2024.

Committee members reviewed and discussed various programs and services provided by the department, analyzing our strengths, weaknesses, opportunities, and threats. Through open and collaborative discussion, the committee developed eight goals and twenty-two associated objectives that will guide our departments direction over the next three years. The plan will be re-evaluated at least annually to measure our progress toward meeting these goals and objectives, and ensure that priorities of the department and the community we serve have not changed. The Strategic Plan and its companion document, the Community Risk assessment and Standard of Cover, will be presented to the YAUFR Commission members in early 2022.



APPARATUS MAINTENANCE

What is a Rescue Truck and what its purpose? This is a question that we occasionally receive from our citizens

York Area United Fire and Rescue provides heavy rescue service to its immediate response areas and assists other areas when technical rescue emergencies occur. Our Rescue Truck, which is designated as Rescue 89, is a 2002 KME heavy rescue unit that carries most of the equipment we use to perform rescues safely. This includes removing people trapped in vehicles, confined spaces, industrial accidents, water rescues, and many other types of rescue or medical emergencies. As part of our ongoing rescue program, crews spend hundreds of hours training and maintaining their skills every year. Rescue 89



carries over five hundred items, including power tools, lifting jacks, cutting torches, hand tools, rope, and hydraulic and pneumatic rescue tools. Each piece of equipment must be inspected and maintained weekly or monthly by the assigned crews.

YAUFR must recertify every three years with the Department of Health and PA State Fire Commissioner's office to verify our readiness, including training and adequately maintained tools and equipment. This voluntary certification program requires a full inspection of our personnel's training records and a complete inspection of our apparatus and tools. We recently completed the recertification process, and once again crews did a fantastic job helping YAUFR recertify to the highest level of "Advanced Rescue".





KEEPING YOUR FAMILY SAFE

Protecting your family, on and off the job.

HOLIDAY SAFETY AWARENESS

The holidays are upon us! Each year this means time with friends and family, and the chance to decorate our homes for the season. When you do, we want to remind you to do so safely!

• Candles should never be left to burn in a room unattended, and they should always be kept away from any item that could ignite!

• If you choose to have a live holiday tree, cut approximately 2" off of the bottom before you place it into your stand. This will ensure that water has a fresh and open area to use when helping to keep your tree vibrant for the entire season.

• Be sure to water your tree daily. Trees can dry out rapidly and become a fire hazard in your home

• Regardless of the type of tree you display, be sure that it is at least 3' - 5' away from any heat source. This includes fireplaces, pellet stoves, or a wood burning stove.

• We all enjoy colorful lights on our tree but be sure to unplug them when you go to sleep or leave your home.



SMOKE DETECTORS

We are sure that by now you know to change the batteries in your smoke alarms when you change your clocks. But if you forgot, there is no time like the present! Should you find that your alarm is not working, is over ten years old, or if you just don't have one - they can be purchased at any hardware store.
