1. CALL TO ORDER

He noted the process to update the plan is required every two years. He noted the updates have already been reviewed and approved by the other three townships at their meetings.

HOFF Chief Hoff indicated in the past they have had new requests for the plan, which are obtained through the County EMA. They also requested copies of the plan for healthcare settings if needed for their licensure. However, he noted at this time there is no list and it continues on a case-by-case request.

HUNT Chairman Hunt asked Solicitor Hovis to comment as a result of the three townships who already reviewed and approved it, as to what YAUFR's role is in approving the updated plan.

HOVIS Solicitor Hovis stated all four townships need to approve it because they delegate the authority to implement it by administration.

HUNT Chairman Hunt called for a motion.

MR. DVORYAK MOVED TO APPROVE THE YORK AREA REGIONAL EMERGENCY MANAGEMENT EMERGENCY OPERATIONS PLAN. MR. WURSTER WAS SECOND. BY ROLL CALL VOTE THE WAS UNANIMOUSLY CARRIED.
