#### **CALL TO ORDER**

# A. Opening Ceremony

# A. Solicitor Walter Tilley

**TILLEY** Solicitor Tilley indicated he provided several comments to Chief Hoff regarding job

description revisions. He commended the command staff on the revised job

descriptions.

Solicitor Tilley reported that Solicitor Hovis is returning to work part-time following his recovery and will continue as Solicitor for YAUFR as his recovery permits.

#### B. Daniel Hoff, Fire Chief

#### **HOFF**

Chief Hoff provided a copy of his report, noting the emailed version had an incorrect date. He reported last evening YAUFR responded to a structure fire caused by a vehicle fire in the Fayfield neighborhood. This morning YAUFR assisted with a second alarm double fatal fire in York City.

Chief Hoff noted under Section 4A in his report the billboards are active which promote volunteer recruitment for YAUFR.

He noted the application period closed at the end of May. There were 33 applications and applicants will be taking the written tests on July 8.

Chief Hoff reported they received 500 smoke alarms donated by the New York City Fire Foundation and KIDDIE Corporation.

Chief Hoff reported an interview was held with York Daily Record in which he was requested to talk about comments he made at the Manchester Township Board of Supervisors regarding the county-wide burn ban as it applies to fireworks. Those comments were also given at the Spring Garden Township meeting as well. He noted he met with Springettsbury Township Manager, Mr. Hodgkinson who concurred with Chief Hoff about the situation.

Chief Hoff noted in his report, Section 3 under Equipment – Springettsbury Township volunteers are taking delivery of a new utility truck which will be used for traffic control. After discussion as to how to proceed with removing the existing truck which has a plow, they are donating it to YAUFR. Chief Hoff indicated they are looking into grant opportunities to determine if they could obtain brush fire equipment for the truck.
